Application Area

Product Description

GREVEN® SOFT K is a mild body cleansing lotion with good cleaning properties and an excellent skin compatibility.

Product Properties

- The balanced combination of high-quality ingredients guarantees a gentle and effective cleansing of the skin.
- Coco-glucoside, a sugar surfactant based on coconut oil and glucose, is a very gentle skin cleansing agent.
- Conditioning and moisturizing ingredients (e.g. allantoin) have a balancing influence on the skin's water management and prevent it from drying-out.
- Glyceryl oleate has a balancing effect on the skin's lipid content and hydrolyzed rice protein makes the hair smooth and easier to comb.
- The product is adapted to the natural pH-value of the human skin. Therefore, it is also suitable for sensitive skin.
- GREVEN® SOFT K PURE is HACCP compliant and, thus, especially suitable for the food industry.

AQUA, SODIUM LAURETH SULFATE, SODIUM CHLORIDE, COCAMIDOPROPYL BETAINE, GLYCERIN, DISODIUM LAURETH SULFOSUCCINATE, HYDROLYZED RICE PROTEIN, GLYCERYL OLEATE, ALLANTOIN, COCO-GLUCOSIDE, SODIUM BENZOATE, POTASSIUM SORBATE, LACTIC ACID, (PARFUM).

Application

Apply GREVEN® SOFT K evenly on the moistened skin. Continue washing adding little water. Rinse off with plenty of water and dry hands thoroughly. If the product gets into the eyes, rinse thoroughly with plenty of water.

Certificate of Dermatological Compatibility

The dermatological compatibility of GREVEN® SOFT K has been carefully tested and proven. A printed certificate is available.

Ecology

The surfactants used fulfill the requirements of easy biological degradability as they are determined in the Regulation (EC) No 648/2004 on detergents. The laboratory testing of surfactants in the context of this regulation is based on the "Confirmatory Test" procedure of the OECD method.

Statutory Regulations

GREVEN® SOFT K is subject to the Regulation (EC) No 1223/2009 on cosmetic products. Further details on handling the product can be obtained from the Group Data Sheets for skin products (for occupational use).

Halal and kosher requirements:

To the best of our knowledge, the ingredients of GREVEN® SOFT K contain neither raw materials of animal origin nor ethanol (excluding unavoidable contamination).

Storage Instructions

The product will keep for at least 30 months (from date of manufacture) if stored unopened at room temperature in the original packaging. The Period After Opening (PAO) is indicated on each tube / bottle / canister.
