## Application Area

GREVEN® SOFT ULTRA is especially suitable for the removal of highly-adhesive dirt e.g. from varnish, resins, adhesives, paint and bitumen.

## Product Description

GREVEN® SOFT ULTRA is a special hand cleanser with dirt-removing additives and natural scrubbing agents made of olive seed powder.

## Product Properties

- GREVEN® SOFT ULTRA is used when common skin cleansing agents based on surfactants fail to perform.
- Varnish, resins, adhesives, bitumen and similar heavily water-repellent dirt cannot be removed from the skin by the mere use of surfactants. Therefore, organic solvents are still often used for these purposes. GREVEN® SOFT ULTRA contains ester oils as dirt-solving component because of their very good skin compatibility.
- The cleansing effect of the product is supported by olive seed powder, whose grain structure and grain fineness are especially adapted to this type of use. Due to its low specific weight, blockages of drains and pipes are not to be expected.
- The entire formulation as well as the pH-value of the product have been adapted to the natural acid mantle of the human skin, which in its functions is not affected by the product.
- Lipid-replenishing ingredients provide an additional caring effect.

AQUA, DIMETHYL GLUTARATE, DIMETHYL ADIPATE, DISODIUM LAURETH SULFOSUCINATE, OLEA EUROPAEA SEED POWDER, BRASSICA CAMPESTRIS SEED OIL, SODIUM LAURETH SULFATE, STEARALKONIUM BENTONITE, PROPYLENE GLYCOL, HYDROGENATED STARCH HYDROLYSATE, LAURETH-4, SODIUM BENZOATE, SODIUM CITRATE, POTASSIUM SORBATE, CITRIC ACID, XANTHAN GUM, PARFUM.

## Application

Apply GREVEN® SOFT ULTRA evenly on the dry skin. Continue washing adding little water. Rinse off with plenty of water and dry hands thoroughly. If the product gets into the eyes, rinse thoroughly with plenty of water.

## Certificate of Dermatological Compatibility

The dermatological compatibility of GREVEN® SOFT ULTRA has been carefully tested and proven. A printed certificate is available.

## Ecology

The surfactants used fulfill the requirements of easy biological degradability as they are determined in the Regulation (EC) No 648/2004 on detergents.

## Statutory Regulations

GREVEN® SOFT ULTRA is subject to the Regulation (EC) No 1223/2009 on cosmetic products. Further details on handling the product can be obtained from the Group Data Sheets for skin products (for occupational use).

## Halal and kosher requirements:

## Storage Instructions

The product will keep for at least 30 months (from date of manufacture) if stored unopened at room temperature in the original packaging. The Period After Opening (PAO) is indicated on each tube / bottle / canister.
