STEPHALEN® OPTIFOAM is exclusively available in 1000 ml NEPTUNE bottles for the NEPTUNE dispenser system. STEPHALEN® OPTIFOAM is HACCP-compliant and can be used safely for personal hygiene in the food industry in consideration of the respective application instructions.

STEPHALEN® OPTIFOAM is based on an innovative, patent-registered surfactant combination which has been developed in collaboration with scientists from the Institute for Interdisciplinary Dermatological Prevention and Rehabilitation at the University of Osnabrück (IDerm) and shows clearly that a systematic combination of surfactants is possible that is both powerful and particularly skin-friendly at the same time. Thus, the new development is a major relief for all those employees who are permanently exposed to severe skin strains, e.g., because they often have to wash their hands.

APPLICATION:

Apply STEPHALEN® OPTIFOAM evenly on the dry skin. For normal dirt, a small amount is sufficient. A proportionally bigger amount is required for hair wash or cleansing the entire body. Continue washing adding little water. Rinse off with plenty of water and dry hands thoroughly.

STEPHALEN® OPTIFOAM is subject to the EU Cosmetics Regulation, but not to the German Chemicals Act or the Hazardous Substances Order.

ENVIRONMENT:

All bottles are made of polyethylene and after being completely emptied, they can be disposed of with other polyethylene waste. Packaging is labeled accordingly.

The surfactants used fulfill the requirements of easy biological degradability as they are determined in the Regulation (EC) No 648/2004 on detergents.
